Harrison School 2023-2024 TITLE I OVERVIEW

<u>What is Title I?</u> Title I is a federally funded program to ensure that students have a fair, equal, and significant opportunity to obtain a high-quality education and to reach, at a minimum, proficiency with challenging academic standards in reading and math.

<u>Who are the Title I Staff Members at Harrison School?</u> Teacher Cassie Norden and paraprofessional Rhonda Lippis and Kim Oxley. These staff members work with students in grades kindergarten through fifth.

How is Parental Involvement Encouraged by Title I?

- \$2,335 (\$7.58 per student, based upon October 2023 Count) is set-aside to support parent involvement for K-5th grade students. This includes supplies for Open House/Back-to-School, Parent/Teacher Conferences, brochures for parents regarding instructional strategies, child care for parents when attending family nights, and supplies for Family Nights.
- **\$1,940** is set-aside to support parent involvement for 6th 8th grade students. This includes supplies for Open House/Back-to-School, Parent/Teacher Conferences, brochures for parents regarding instructional strategies, child care for parents when attending family nights, and supplies for Family Nights.

What financial support is given by Title I funds to Harrison School? Title I allocations are based on the number of students who qualify for free/reduced lunch. 71% (K-5) of the students qualified for free/reduced meals (as of October Count, 2019). For the 2023- 2024 school year, Harrison School will receive approximately \$157,211 in Title I Funds to support the following:

- Salaries for staff noted above.
- An additional \$1,750 of salary, and \$508 of benefits, is being allocated out of 4010/Title One for MTSS.
- An additional \$3,500 of salary, and \$1,016 of benefits, is being allocated out of 4010/Title One for BLT.

<u>What is the Title I School Improvement Plan?</u> The Title I School Improvement Plan is the Harrison School Accreditation/Accountability Plan. The school goals are revised each fall.
